### 11.1. Facility Feasibility Study Follow Up Discussion

Dr. Lutz reviewed the handout that was created in conjunction with input from HHSDR in the 2018 feasibility study. He outlined the following factors:

- Improvements to the building are more complex and additional byproduct work would need to be done regarding HVAC repairs.
- Estimated cost breakdown figures are from 2018 and would need adjusted by 30% increase.

vote to reappoint **Tricia Cousino** as Board Secretary for a term of four years beginning

Mr. Comensky spoke in agreement regarding the cost increases for repairs discussed by Dr. Lutz and added these increases would be regardless even if construction products were not needed from overseas companies.
